Accreditation for Continuing Medical Education (CME) credits may be provided by the company based on compliance with approved accreditation process. The PostGraduate Assembly in Anesthesiology (PGA) does not accredit Satellite Symposia. If CME is provided as part of your satellite symposium, it is necessary that any advertisements or announcements for the program must clearly state that the session is outside the hours and not related to the PostGraduate Assembly Program.
3. Brochures promoting symposium will be distributed at the registration area if provided by the sponsoring company. Brochures are required to state:
A - This program is not associated with or part of the 68th PostGraduate Assembly in Anesthesiology.
B - Funds for this program have been provided by an unrestricted grant from (name of your company).
4. The PGA will have one sign listing all satellite symposia in the registration area.
5. The sponsoring company will be responsible for all expenses related to their symposium, including room rental, audiovisual, food and beverage, speaker expenses, honoraria, etc. The company can not offer monetary incentives to delegates to attend their symposium.
